LETTER OF AGREEMENT

Between Detour Education Association And the Detour Area Schools

The Board of Education of Detour Area Schools and the Detour Education Association agree that the current contract which expires August 31st, 2020 shall be extended to August 31st, 2022. During the term of this interim agreement, all terms and conditions of the current contract shall be in full force and effect and shall be adhered to.

The Agreement that was entered into by and between the Detour Education Association as represented by the Northern Michigan Education Association/MEA/NEA the first day of September 2018 and that remains in effect until the last day of August 31st, 2020, shall be extended to August 31st, 2022. This extension has been agreed upon due to the unprecedented situation currently being faced by our community and our world as it relates to the COVID-19 pandemic.

The language in the current agreement will be in full force for an additional year, specifically, but not limited to:

- 1) Teachers will earn one step on the salary schedule.
- 2) Detour Area Schools will pay the full hard-cap amount for the 2020-2021 and 2021-2022 school year as set by the State of Michigan in September of each year.
- 3) Any teacher who has completed advanced academic work and is eligible for a "lane change" will be granted a change.
- 4) The calendar committee will continue their work to establish a workable calendar for the school years covered by this agreement, that is in accordance with the Michigan School Code requirements.
- 5) The annual (2%) percentage increase as negotiated in the September 1, 2018 to August 31, 2020, will be extended for the 2020-2021 school year. For the 2021-2022 school year the 2% increase will be honored unless the general fund balance of Detour Area School goes below 10% as indicated by the June 2021 audit and Profiles data collected by the Michigan Education Association. If the general fund balance dips below 10%, both parties shall meet to review the 2% increase.
- 6) The two-year term as negotiated in the September 1, 2018 to August 31, will be extended.

This Letter of Agreement shall not create a past practice or establish precedence.
