## **Board/Association Agreement Extension of Master Agreement 2005-08**

The Okemos Public Schools' Board of Education and the Okemos Custodial/Maintenance/Food Service Units MEA/NEA agree to extend the current 2005-08 collective bargaining agreement from July 1, 2008 through June 30, 2009.

All of the provisions of the 2005-08 Master Agreement will remain the same with the following additions:

#### Additional Wages:

- 1. .27% increase off schedule equates to 25% of the savings from changing health insurance plans (from MESSA Tri-med to MESSA Choices II with a \$10/\$20 drug card.)
- 2. If the blended enrollment count (25% of February, 2008 and 75% of September, 2008) for the 2008-2009 school year decreases less than or equal to 40 FTEs from the 2007-2008 blended count (4157.76 FTEs), the bargaining unit members will receive an additional .25% increase on the salary schedule. This will be paid on or before the 2<sup>nd</sup> pay in March, 2009.

#### **Other**

- Beginning July 1, 2008, Food Service employees must work at least 4 hours per day (20 hours per week) to be eligible for life and single coverage dental and vision. Further, a food service bargaining unit member must work at least six (6) weeks before being eligible for benefits.
- Bargaining unit members hired prior to July 1, 2008 will be grandfathered and maintain their current insurance coverage.
- The Board will provide a vision program as follows:

An employee requiring a vision examination every twelve (12) months for medical reasons will have a benefit of \$58 each year. A medical statement must be forwarded to the Deputy Superintendent to initiate this plan.
