
STIPULATION AND ORDER OF DISMISSAL

The parties stipulate to dismiss with prejudice this action brought pursuant to the Michigan Freedom of Information Act, MCL 15.231 *et seq.*, (“FOIA”), upon the Court’s approval of this stipulation and order expressly incorporating herein the terms of this agreement as follows:

1. That Michigan State University (the “University”) has disclosed a portion of the records requested by Plaintiff.
2. That the Plaintiff agrees to dismiss this suit with prejudice, with each party to bear their own fees and costs, including attorneys’ fees.

3. That this Stipulation constitutes the full and complete satisfaction of any and all claims arising from the allegations set forth in the complaint and any and all claims arising from Plaintiff's FOIA request(s) which gave rise to this suit.
4. That this Stipulation does not constitute an admission of liability or fault on the part of the University, and is entered into by both parties for the purpose of resolving disputed claims and avoiding further litigation.
