In the case of paperwork being returned on the same date, position on the list shall be determined by lot. a driver(s) hired with all credentials (current CDL, appropriate endorsements, etc.) will obtain the first seniority date. If two (2) or more employees are hired with all credentials, seniority shall be determined by lot. Thereafter, seniority shall be in order of when the road test was passed. If two (2) or more employees pass the road test on the same date, seniority is determined by lot.
