1 in this agreement shall refer to all members of the above defined unit. All references to the male gender shall  
2 automatically be so construed as to include the female gender and vice versa.

3 Section C: The Board agrees that for the duration of this agreement that it will not negotiate with any union, group  
4 or individual other than the union with which this agreement is made concerning hours, rate of pay or any terms  
5 or conditions of employment affecting the bargaining unit member as defined above.

6 **ARTICLE 2: UNION RIGHTS AND SECURITY**

7 Section A: Employees covered by this agreement at the time it becomes effective shall be required to continue or  
8 become members in the union or pay a service fee equal to the national, state and local dues for the duration of this  
9 agreement as a condition of continued employment.

10 Section B: The employer agrees to deduct dues and initiation fees, upon written authorization from the employee,  
11 within thirty (30) days of employment or the date on which this agreement becomes effective from a regular  
12 paycheck each month - September through June

13 Section C: The employer agrees to deduct service fees upon written authorization from employees covered by this  
14 agreement who are not members of the union within thirty (30) days of employment or the date on which this  
15 agreement becomes effective from a regular paycheck each month - September through June or terminate that  
16 employee's employment within thirty (30) days.

17 Section D: As a condition of the above, the union agrees to indemnify the Board and each individual Board  
18 member for any costs or damages which may be assessed against the Board as a result of suit or action resulting  
19 from this agency shop provision provided that:

1           1.       The union shall assume the sole defense of this agency shop clause and choose legal counsel to  
2                    defend it.

3           2.       The union shall have the right to compromise or settle any claim made against the board under  
4                    this Article.

5       Section E: The employer agrees to promptly remit to the union any and all monies so deducted each month  
6       accompanied by an alphabetized list of all employees from whom deductions of dues and service fees have been  
7       made.

8       Section F: The union shall be provided with bulletin board space in the following locations: high school office,  
9       main kitchen, serving kitchen, receiving area, and bus garage for the purpose of posting union materials. The union  
10       shall also have the right to use the school mails to distribute union materials.

11       Section G: Special conferences for important matters will be arranged between the union president and the  
12       representative of the employer upon the request of either party. Such meetings shall be between at least two (2)  
13       representatives of each party.

14       Section H: The union shall have the right to use school facilities for meetings, and school equipment such as  
15       typewriters, duplicating equipment and audio visual equipment. The union agrees to pay reasonable costs related  
16       to the use of such materials.

17       Section I: Employees shall be represented by elected and/or appointed officers and stewards. The union shall  
18       furnish the names of officers and stewards upon their election or appointment. The stewards may represent and/or  
19       investigate and present grievances to the employer during hours in which the employee is not scheduled to work.

20       Section J: In accordance with applicable laws concerning the right to information, the employer agrees to furnish

1 the union with information which is available concerning, but not limited to, financial budgetary and employee  
2 salary status which is necessary for the development and processing of grievances and/or negotiating proposals.

3 Section K: The duties of any bargaining unit member or the responsibilities of any position in the bargaining unit  
4 shall not be altered, increased or transferred to persons not covered by this agreement.

5 1. The employer agrees that administrators, teachers, supervisors as described by PERA, and non-unit  
6 personnel shall not be used at any time to displace employees regularly employed in the bargaining unit,  
7 except in emergencies when union employees are not available or have refused to do the work assigned  
8 except in cases where unsafe conditions are being charged by an employee. An emergency shall be  
9 defined as an unforeseen circumstance which calls for immediate action in a situation which  
10 is not expected to be of a recurring nature.

11 Section L: The employer shall provide five (5) unpaid released days in whole or half day segments to the union  
12 President or his/her designee for the annual conduct of business at union conferences as deemed appropriate by the  
13 union president. Employees, where possible, may make up any time missed by making arrangements with their  
14 immediate supervisor.

15 **ARTICLE 3: EMPLOYEE RIGHTS**

16 Section A: Pursuant to the Michigan Employment Relations Act, the employer hereby agrees that every employee  
17 shall have the right freely to organize, join and support the union for the purpose of engaging in collective  
18 negotiations or bargaining. As a duly elected body, exercising governmental power under color of law of the State  
19 of Michigan, the employer undertakes and agrees that it will not directly, or indirectly, discourage, deprive or coerce

1 any employee in the enjoyment of any rights conferred by the Act or other laws of Michigan, or the Constitutions  
2 of Michigan or the United States of America; that it will not discriminate against any employee with respect to  
3 hours, wages or any terms or conditions of employment by reason of his/her membership in the union or collective  
4 negotiations with the employer, his/her institution of any grievances or complaint, or proceeding under this  
5 agreement, or otherwise with respect to any terms of conditions of employment.

6 Section B: Employees shall be entitled to full rights of citizenship and no religious or political activities of any  
7 employee or lack thereof shall be grounds for any discipline or discrimination with respect to the employment of  
8 such employee. The private and personal life of the employee is not within the appropriate concern or attention  
9 of the employer unless such private and personal actions interfere with job performance or responsibilities.

10 Section C: Residence within the district shall not be a requirement of employment.

11 Section D: No employee shall be disciplined (including warnings, reprimands, suspensions, reduction in rank or  
12 occupational advantage, discharges or other actions of a disciplinary nature) without just cause. Just cause shall  
13 be deemed to include, but not limited to: conviction of a felony, falsification of personnel records and provable  
14 willful insubordination and/or physical violence to administrative personnel. Specific grounds forming the basis  
15 of or for such disciplinary action shall be made available to the union.

16 Section E: An employee shall be entitled to have present a representative of the union during any meeting which  
17 leads or may lead to disciplinary action. If disciplinary action seems likely, the employer agrees to so advise the  
18 employee.

19 Section F: The employer agrees to comply with and provide access to personnel records as defined and allowed  
20 under P.A. 442 of the Public Acts of 1976 and P.A. 397 of the Public Acts of 1978. Further, the employer agrees

1 to verbally notify the employee of the pending inclusion of any reprimand(s), written warning(s), or the  
2 complaint(s) relating to the employee prior to its inclusion in the employee's personnel file. Parental and student  
3 complaints shall first have been notified verbally and the complaint was properly investigated and verified by the  
4 employer. The complaint shall be initialed by both parties prior to inclusion. If employee refuses to initial a  
5 complaint the Union will agree to initial the complaint on behalf of the employee. Such notation indicates only  
6 awareness of said complaint and in no way implies agreement with or guilt or responsibility for content of the  
7 complaint.

8 Section G: Any case of assault upon an employee in or on school property shall be reported to the employer. The  
9 employer shall promptly render all reasonable assistance to the employee in connection with the handling of the  
10 incident by law enforcement and judicial authorities.

11 **ARTICLE 4: BOARD RIGHTS**

12 Section A: The Board, on its own behalf and on behalf of the electors of the district, hereby retains and reserves  
13 unto itself, without limitation, all powers, rights, authority, duties and responsibility conferred upon and vested in  
14 it by the laws and the Constitution of the State of Michigan and of the United States, including, but without limiting  
15 the generality of the foregoing, the right:

- 16 1. Manage and control the school's business, the equipment, the operations and to direct the working forces  
17 and affairs of the employer.
- 18 2. Continue its rights of assignment and direction of work of all of its personnel, determine the number of  
19 shifts and hours of work and starting times and scheduling of all the foregoing, but not in conflict

1 with the specific provisions of the Agreement, and the right to establish, modify or change any work or  
2 business hours or days.

3 3. The right to hire, promote, suspend and discharge employees for just cause, transfer employees, assign  
4 work or extra duties to employees, determine the size of the work force and to lay off and recall employees.

5 4. Determine the services and supplies and equipment necessary to continue its operations and to determine  
6 the methods, schedules and standards of operation, the means, methods and processes of carrying on the  
7 work including automation thereof or changes therein, the institution of new and/or improved methods or  
8 changes therein.

9 5. Adopt reasonable rules and regulations.

10 6. Qualifications will be determined by job description, the 90 day probationary period and state laws and  
11 certifications.

12 7. Determine the location or relocation of its facilities, including the establishment or relocations of new  
13 schools, buildings, departments, divisions or subdivisions thereof and the relocation or closing of offices,  
14 departments, divisions or subdivisions, buildings or other facilities.

15 8. Determine the placement of operations, production, services, maintenance or distribution of work, and the  
16 sources of materials or supplies.

17 9. Determine the financial policies, including all accounting procedures and all matters pertaining to public  
18 relations.

19 10. Determine the size of the management organization, its functions, authority, amount of supervision and  
20 table of organization provided that the employer shall not abridge any rights from employees as specifically  
21 provided for in the Agreement.

1 Section C: An employee shall lose seniority only for the following reasons: if his/her employment is terminated  
2 for just cause, he/she quits, resigns, retires, is transferred to a non-bargaining unit position, or is certifiably going  
3 to be absent from the job due to long term disability and will not be returning to the job.

4 Section D: Seniority shall continue to accrue for all bargaining unit members on paid leave of absence, disability  
5 for not more than one and one-half (1 1/2) years, pregnancy leave, sick leave or other leave where the employee's  
6 employment is considered to be continuous. An employee returning from more than one and one-half (1 1/2) years  
7 of disability or a non-bargaining unit position shall be entitled to reinstatement of seniority held prior to the  
8 disability or transfer.

9 **ARTICLE 6: LAY-OFF AND RECALL**

10 Section A: It is hereby specifically recognized that it is within the sole discretion of the Board to reduce its  
11 educational program, curriculum and/or staff and that the procedures set forth in this Article shall be used in laying  
12 off personnel. Lay off shall be defined as a necessary reduction in the work force.

13 Section B: No employee shall be laid off pursuant to a necessary reduction in the work force unless said employee  
14 shall have been notified of said lay-off at least ten (10) working days in advance of the effective date of the lay-off  
15 in writing. The district will notify employee five (5) days in advance of a permanent reduction in working hours.

16 Section C: In the event of a necessary reduction in the work force the employer shall first lay off the least senior  
17 employees. In no case shall a new employee be hired by the district while there are laid off employees who meet  
18 the qualifications for a vacant position or a newly created position as defined by the job description. Employees  
19 whose positions have been eliminated due to a reduction in the work force or have been affected by a lay-off shall

1 have the right to assume a position for which they meet the qualifications per the job description which is held by  
2 a less senior employee.

3 Section D: In the event of a reduction in the work hours in a classification, an employee may claim seniority over  
4 another employee for the purpose of maintaining his/her normal work schedule.

5 Section E: A laid-off employee shall be given preference in substituting when the need for a substitute arises in  
6 the district. Laid-off employees shall also be allowed to continue health, dental and life insurance benefits by  
7 paying the regular monthly subscriber group rate premium to the employer.

8 Section F: Laid-off employees shall be recalled in the reverse order of lay-off to any position provided employee  
9 meets the qualifications as contained in the job description. The employee will be determined to be assigned to that  
10 position after a probationary period of ninety (90) days. Following a ninety (90) day probationary period the  
11 employee's supervisor will evaluate that performance and in consultation with the Superintendent determine  
12 competency for the position assigned.

13 Section G: Notice of recall shall be sent to the employee at his last known address by registered or certified mail.  
14 If an employee fails to report to work within ten (10) working days from the date of mailing the notice of recall,  
15 he/she shall be considered to have quit. In proper cases, exceptions may be made.

16 Section H: Employees on lay-off shall retain their seniority and be eligible for recall for two (2) years.

17 **ARTICLE 7: VACANCIES, PROMOTIONS AND TRANSFERS**

18 Section A: A vacancy shall be defined as a newly created position or a present position that is not filled in the  
19 bargaining unit. If at any future date a position is created within the district, the Board will place such position in

1 the proper job classification. If a new position is created or the duties of an existing position change, the Board of  
2 Education will receive input from the union President and those person/s most likely to be affected by the changes  
3 prior to finalizing the new job description. The union recognizes the right of the Superintendent/Board of  
4 Education to make the final decision.

5 Section B: The union president and union steward shall be notified in writing of all vacancies during the school year.  
6 Vacancies will be posted for a period of five (5) days during which time employees may apply for a vacant position  
7 in writing. The employer agrees to notify employees of vacancies during the summer months by sending notice  
8 of the vacancy to all bargaining unit members.

9 Section C: Vacancies shall be filled with the most senior applicant who meets qualifications per the job  
10 description. If no one within the bargaining unit applies, the vacancy shall then be offered to laid off employees  
11 if their qualifications are in accordance with the job description.

12 Section D: The district agrees to provide substitutes when temporary vacancies occur in the district. Temporary  
13 assignments for the purpose of filling vacancies of employees who are on vacation, or are absent due to illness for  
14 a period of more than five (5) days will first be granted to the most senior employee meeting qualifications per  
15 the job description upon application for the vacant position. In this instance and only in this instance shall the  
16 posting period be shortened to two (2) days to limit the disruption in the district. Such employee shall receive the  
17 rate of higher pay of a higher classification for all hours worked while filling such vacancy. After the vacancy has  
18 been offered to employees within the bargaining unit, it shall then be offered to employees on lay-off.

19 Section E: A promotion shall be defined as an upward change in an open job classification which results in  
20 additional pay. Promotion shall be made on the basis of seniority and qualification. The most senior applicant for

1 the promotion who meets the qualifications in accordance with the job description shall be granted a thirty (30)  
2 working day trial period to determine his/her ability to perform the work and his/her desire to remain on the job.  
3 If the employee is unable to perform the work or at his/her option, the employee shall be returned to his/her previous  
4 assignment.

5 Section F: In the event the senior applicant is denied the promotion after the trial period, reasons for the denial shall  
6 be given in writing to the employee and the union.

7 Section G: During the trial period, employees shall receive the rate of the job they are performing.

8 Section H: Employees shall not be placed on a lower wage scale due to involuntary transfers and the union and the  
9 district agree that involuntary transfers are to be minimized and avoided whenever possible. In all cases,  
10 involuntary transfers will be effective only for reasonable and just cause.

11 Section I: When positions become vacant or are created, bargaining unit members may be allowed to hold more  
12 than one (1) position within the district provided seniority requirements are met, the employee meets qualifications  
13 of the job description, and the schedule of the extra position does not conflict with the regular schedule of the  
14 bargaining unit member.

15 Section J: When a position has an increase in time of 30 minutes or more, the additional time shall be posted as set  
16 forth in this contract.

17 Section K: Employees may substitute in other positions at the discretion of the immediate supervisor. Substitute  
18 assignments will be made which minimize the disruption of services.

**ARTICLE 8: GRIEVANCE PROCEDURE**

1  
2 Section A: A grievance is a complaint involving alleged violation of this contract. If any such grievance arises,  
3 there shall be no stoppage or suspension of work because of such grievance. For the purpose of representing the  
4 employee effectively within the jurisdiction of this agreement grievances shall be:

5 **STEP 1:** Presented in writing to the supervisor and signed by the employee and/or union representative within ten  
6 (10) working days of the alleged violation. Disposition of the grievance by the supervisor shall be returned to the  
7 employee and/or union representative in writing within five (5) working days.

8 **STEP 2:** If the grievance is not resolved in STEP1, the employee and/or the union may within five (5) working  
9 days of receipt of the supervisor's answer, submit to the Superintendent or his/her designee a signed written  
10 "Statement of Grievance." A copy shall be given to the supervisor involved at the time. The "Statement of  
11 Grievance" shall identify all of the provisions of this agreement alleged to have been violated by appropriate  
12 reference, shall state the contention of the employee and of the Association (Union) with respect to these provisions,  
13 shall indicate the relief requested, and shall be signed by the employee and/or union representative involved. Within  
14 five (5) working days of receipt of the grievance, the Superintendent shall meet with the union in an effort to resolve  
15 the grievance. The Superintendent shall indicate his/her disposition of the grievance in writing within five (5)  
16 working days of such meeting and shall furnish a copy thereof to the union.

17 **STEP 3:** Grievance unresolved in the two (2) STEPS above shall go to a hearing before the Board of Education  
18 at the next regularly scheduled Board meeting.

19 **BINDING ARBITRATION:** If a satisfactory decision on the grievance is not made as a result of the Board of  
20 Education meeting either the Board or the Association shall have the right to appeal the dispute to an impartial

1 arbitrator under and in accordance with the rules and regulations of the American Arbitration  
2 Association (AAA). Such appeal must be taken within fifteen (15) working days of the decision of the Board. The  
3 arbitrator's ruling is limited to the relief without modification, in accordance with all provisions set forth in this  
4 Agreement.

5 Section B: Time limits provided in the Article shall be strictly adhered to but may be extended in writing by mutual  
6 agreement.

7 Section C: Notwithstanding the expiration of the agreement, any claim or grievance arising hereunder shall be  
8 processed through this procedure until resolution.

9 Section D: If any bargaining unit member for whom a grievance is sustained, shall be found to have been unjustly  
10 disciplined or discharged, he/she shall be promptly reinstated with full reimbursement for all compensation lost,  
11 and have his/her record cleared of any reference to this action.

12 Section E: Grievance records and references shall be stored in a file separate from the employee's personnel file.

13 Section F: The fees and expenses of the arbitrator shall be shared equally by the Board and the Association. All  
14 other expenses shall be borne by the party incurring them, and neither party shall be responsible for the expense  
15 of witnesses called by the other.

16 **ARTICLE 9: WORKING CONDITIONS**

17 Section A: The district shall provide a one-half (1/2) hour paid lunch period for bargaining unit employees who  
18 work seven (7) or more continuous hours. Such lunch periods shall be taken at a time which is not in conflict with  
19 the employee's normal working duties.

1 Section B: On those days where school has been canceled for students and there is not penalty from the State Aid  
2 Act, school year support staff employees in the bargaining unit need not report for work with no employee suffering  
3 a diminution of pay. Custodial-maintenance employees who work year round, however, shall be expected to report  
4 for work. If school is canceled after it has started and students are sent home, school year employees shall be  
5 entitled to go home once the building and work materials of the employee have been adequately closed and/or cared  
6 for. Those employees already at their work station as scheduled will be paid from the time their job commences  
7 until their work stations are adequately closed and/or cared for. It is the employee's responsibility to be in a  
8 position of contact. Determination of cancellation will be made by the Superintendent or designee and  
9 communicated to employees as soon as possible. Any days required to be made up will be compensated for as  
10 regular work days.

11 Section C: Employees who work from four (4) up to eight (8) continuous hours shall be entitled to one (1) fifteen  
12 (15) minute relief period. Employees who work eight (8) hours shall be entitled to two (2) such  
13 relief periods. Employees working overtime shall be entitled to one (1) fifteen (15) minute relief period for every  
14 two (2) hours worked.

15 Section D: The employer agrees that no employee shall be required to work under unsafe or hazardous conditions.  
16 Further, the employer agrees to provide without cost to the employee, necessary safety equipment, not to include  
17 ordinary equipment, for the performance of their regular duties. First aid kits shall be available in the employee's  
18 immediate work area for employee use.

19 Section E: Each employee shall be covered by the applicable Worker's Compensation Laws.

20 Section F: No employee in the bargaining unit shall be required to dispense medication to any other person,  
21 including students.

1 day of their annual allowance to the next year. Employees that work less than 1750 hours per year may accumulate  
2 up to four (4) personal business days in any one year. Employees that work 1750 or more per year may accumulate  
3 up to five (5) personal business days in any one year. If personal days are not used during the year or carried over  
4 to the next year, the employee may elect to be paid one-half (½) of his/her daily salary for the unused days, or  
5 convert unused days to sick days. Employees may use personal leave time before or after vacations/holidays at the  
6 discretion of their immediate supervisor. A limit of one staff member per classification may use personal leave time  
7 before or after each vacation or holiday. Such days shall be granted on a departmental seniority rotation basis under  
8 Association auspices. A one (1) week notice is required prior to approval of a personal leave. Requests for personal  
9 leave during hunting season may be granted per this section for both school year and year round employees.  
10 Emergency situations will be considered.

11 Section C - Maternity Leave: In the event an employee has insufficient sick leave accumulated or does not wish  
12 to use up her paid sick leave, she will notify the district at least one hundred twenty (120) days prior to the expected  
13 delivery date of the baby of her intent to use this unpaid leave provision. An emergency or complication during  
14 delivery or following it, however, shall be reason for exception to the notification time period. During any  
15 maternity leave, the employee will be allowed to continue work until such time as the employee is not longer  
16 physically able to work as soon as she is physically able to do so as certified by her physician for up to a maximum  
17 of six (6) weeks or the length of the accumulated sick leave. Employee fringe benefits shall be maintained by the  
18 district with the employee being returned to the same position upon return to work, as held prior to the leave.

19 Section D - Personal Sick Leave Extension: Any employee whose personal illness (as defined in Section A above)  
20 extends beyond the period compensated shall be granted a leave of absence without pay for such time as is  
21 necessary for complete recovery from such illness up to one (1) year. The employee may continue insurance

4 Section E - Bereavement Leave: Up to three (3) days with pay shall be granted for the death in the employee's  
5 immediate family which shall be defined to include father, mother, spouse, children, grandparents, brothers, sisters,  
6 grandchildren, parent-in-law or IRS dependent living in the immediate household.

7 Section F - Jury Duty/Court Appearance - An employee who is a plaintiff or defendant not related to district service,  
8 before any judicial or administrative tribunal, shall not be compensated, unless personal business days are used for  
9 the time missing from normal duties. A leave of absence with pay, not charged against an employee's sick or  
10 personal leave, will be granted if an employee is called for court appearances as a witness in any case in which the  
11 employee's connection with the case stems from his/her employment with the Board, provided the legal action is  
12 not instigated by or on behalf of the employee or the Association against the Board. The employee shall be  
13 compensated for the time missed coinciding with the normal work hours, the difference between normally earned  
14 wages and the pay received from the performance of such obligation. An employee called for jury duty before any  
15 judicial or administrative tribunal shall be compensated for the time off coinciding with normal work hours, the  
16 difference between normally earned wages and the pay received from the performance of such an obligation.

17 Section G - Military Leave: Military leaves of absence shall be granted to any employee who shall be inducted or  
18 shall enlist for military duty to any branch of the armed forces of the United States. Employees on military leave  
19 shall not be given the benefit of increments or fringes as if they had remained in active service to the school system.  
20 Seniority held by the employee prior to this leave shall be reinstated to the employee upon return to work but shall  
21 not accrue during the leave. The employee shall be entitled to return to the same job held prior to the leave.  
22 Military leave will be limited to one (1) tour of duty with a maximum of four (4) years.

1 Section H - Workman's Compensation: Absence due to injury which is compensable under Workman's

4 service to the Rapid River School District upon the employee's request. The employee must request the leave in  
5 writing by May 1 for the ensuing year and notify his intention to return to the district by June 1 of the following

9 Section A: At least sixty (60) days prior to the expiration of this agreement, the RRESP bargaining team shall

11 year(s). Negotiations shall begin during this time.

12 The parties acknowledge that during the negotiations of this agreement, each had unlimited right and opportunity  
13 to make demands and proposals with respect to any subject or matter not removed by law from the area of collective  
14 bargaining and that the understanding and agreements arrived at by the parties after the exercise of that right are  
15 set forth in this agreement. Therefore, the district and the union waive the right, and each agrees that the other shall  
16 not be obligated to bargain collectively for the duration of this agreement with respect to any subject or matter  
17 whether covered or not by this agreement. Provided, however, that by mutual written agreement of the parties this  
18 agreement may be re-opened for negotiations but that any amendment or supplemental agreement shall not be  
19 binding unless executed in writing and signed by the parties.

20 Section B: Neither party in any negotiations shall have any control over the selection of the negotiating or  
21 bargaining representatives of the other party and each may select its representatives from within or outside the  
22 school district. While no final agreement shall be executed without ratification by the union and the Board of

1 Education, the parties mutually pledge that their representatives will be clothed with all necessary power and  
2 authority to make proposals, consider proposals, and make concessions in the course of negotiations, subject only  
3 to such ultimate ratification.

4 Section C: If the parties fail to reach an agreement in any such negotiations, either party may invoke the mediation  
5 machinery of the Michigan Employment Relations Commission or take any other lawful measures it may deem  
6 appropriate.

7 Section D: When negotiations are conducted during the employee's regular work hours at the request of the state  
8 mediator, released time shall be provided for the union's negotiating team members.

9 **ARTICLE 12: MISCELLANEOUS PROVISIONS**

10 Section A: It is agreed that this agreement is the sole agreement between the parties and as such shall supersede  
11 any rules, regulations, or practices of the district which shall be contrary to or inconsistent with its terms. The  
12 provisions of this agreement shall be incorporated into and be considered a part of the established policies of the  
13 district and supersedes or cancels all previous agreements.

14 Section B: If any provision or application of this agreement to any employee or group of employees shall be found  
15 to be contrary to law, then such provision or application shall not be deemed valid and subsisting except to the  
16 extent permitted by law, but all other provisions or applications shall continue in full force and effect.

17 Section C: Copies of this agreement shall be printed at joint expense and distributed to all employees of the district  
18 now employed, or hereinafter employed within thirty (30) days of employment or when this agreement is signed  
19 by both parties. The union shall have the opportunity to have the contract printed provided it is at less expense than  
20 the Board can arrange.

16 Section I: The Board agrees to pay a CDL license fee for employees required to have this license. Should an  
17 employee fail the CDL test the board will not pay the fee more than once. The Board agrees to pay the renewal fee  
18 for the CDL license. Should an employee fail the exam, the payment of the second renewal fee will be the  
19 responsibility of the employee.

1 cost effective, and in accordance with District Policy. Outside groups and organizations renting facilities which  
2 necessitate the use of special services will be required to use district personnel. In the event the district shares  
3 transportation with another district, every effort will be made to rotate the use of buses in providing drivers  
4 opportunities for additional hours.

5 Section K: Support staff personnel must meet the certification requirements according to Federal and State  
6 guidelines for the job classification for which they are employed.

7 Section L: Employees who use their personal automobile while performing their job responsibilities shall be  
8 reimbursed at the current Internal Revenue Service rate.

9 **ARTICLE 13: STRIKES**

10 Section A: The union will not authorize, sanction, condone, or acquiesce in, nor will any member of the bargaining  
11 unit take part in any strike or work stoppage of any kind or nature during the duration of this agreement. Strike and  
12 work stoppages shall be deemed to include, but are not limited to slow-downs, stoppages of any kind, sit-ins, "blue  
13 flu", and illegal picketing and demonstrating for the duration of this agreement in reference to the Rapid River  
14 School District.

15 Accordingly, the union agrees that during the term of this agreement, it shall not direct, instigate, participate  
16 in, encourage, or support any strike as defined above, against the Board by any employee or group of employees.

4 to hire temporary workers to replace employees who fear for their safety until such time as they are able to return

7 Section A: The normal work year for support staff employees shall coincide with the number of days school is in  
8 session in order to fulfill state requirements to receive full state aid.

9 High School Secretary who shall work the number of days school is in session, the months of June and  
10 August, and the number of day(s) in July to total 219 days.

**ARTICLE 16: FRINGE BENEFITS**

2 Section A: Employees working a full calendar year shall receive vacation time. Vacation time shall be used at a  
3 time agreeable to both the employer and the employee. In the event more than one (1) employee in a classification  
4 shall request vacation time for the same period, preference shall be given based on seniority.

5 Section B: It is intended that vacation time be used during the work year but in the event the employer encounters

2 Section A: The basic compensation shall be set forth in Schedule A. There shall be no deviation from Schedule  
3 A compensation rates for the duration of this agreement.

4 Section B: The following conditions shall apply to overtime work: Time and one-half (1-1/2) shall be paid for all  
5 hours worked over forty (40) hours in one week.
