LETTER OF AGREEMENT
Between

Lake Shore Federation of Teachers
June 23, 2020

THIS LETTER OF AGREEMENT ("LOA") is made and entered into this 23<sup>rd</sup> day of June, 2020, by and between the Board of Education of the Lake Shore Public School District ("BOARD"), and the Lake Shore Federation of Teachers Local 1465 ("FEDERATION"), to facilitate a one-year extension of the 2019-20 Collective Bargaining Agreement ("CBA") through August 31, 2021.

WHERAS, the FEDERATION is the exclusive bargaining representative for all certified personnel employed by the BOARD, as set forth in Article I, Section 3 of the CBA;

WHERAS, the BOARD and the FEDERATION have agreed to extend the terms of the CBA for a period of one school year and to modify certain provisions of the CBA for the 2020-21 contract year; and

WHEREAS, the BOARD and the FEDERATION have agreed that the terms of this LOA for the 2020-21 contract year as set forth below shall not constitute a precedent for any future agreement, and shall not constitute the status quo of the CBA for purposes of future negotiations.

**NOW, THEREFORE**, in consideration of the promises and mutual undertakings and agreements of the parties hereto, it is hereby agreed by the BOARD and the FEDERATION as follows:

# 1. Term of Agreement

Article X, Section 1 of the CBA is amended to read as follows:

Section 1. Duration of Agreement

- A. This Agreement shall be effective as of September 1, 2020 for a term of one (1) year and shall expire at 11:59 p.m., Eastern Standard Time on August 31, 2021.
- B. The parties agree to undertake negotiations for a new Collective Bargaining Agreement no later than November 1, 2020.

#### 2. Compensation

Appendix B of the CBA is amended to provide a revised salary schedule for the 2020-21 contract year. For the 2020-21 contract, year bargaining unit members who have not reached the top of the pay scale shall advance one step, as determined by applying the 2020-21 Teachers' Salary Schedule, attached as Exhibit 1.

# 3. January 6, 2020 Letter of Agreement

The terms of the parties' Letter of Agreement dated January 6, 2020, attached as Exhibit 2, shall remain in full force and effect.

### 4. <u>Calendar</u>

Appendix A of the CBA is amended to provide a revised calendar for the 2020-21 contract year, attached as Exhibit 3.

### 5. <u>Effect of LOA</u>

Except as otherwise provided in this LOA, the remaining provisions of the CBA will continue in effect through the extended term of the CBA.

#### 6. Non-Precedential

The parties agree that the circumstances leading to the creation of this LOA are unique and that entering into this LOA will not constitute a precedent for any future dealings between the parties concerning the subject matters of this LOA and that the terms of this LOA will not constitute the status quo of the CBA for purposes of future negotiations.

#### 7. Entire Agreement

This LOA sets forth all the promises, agreements, conditions, and understandings between the parties relative to the subject matter hereof. There are no promises, agreements or undertakings, either oral or written, expressed or implied between them other than as herein set forth.

#### 8. Amendment of LOA

Except as otherwise provided, no subsequent alteration, amendment, change, or addition to this LOA shall be binding upon the parties hereto unless reduced to writing and duly authorized and signed by each of them.

## 9. <u>Effective Date</u>

This LOA is effective immediately upon execution by the authorized representatives of the BOARD and the FEDERATION as set forth below.

Letter of Agreement Between Lake Shore Public Schools And Lake Shore Federation of Teachers REVISED- January 6, 2020

The Lake Shore Public Schools, hereinafter known as "District" and the Lake Shore Federation of Teachers, hereinafter known as the "Federation", hereby agree to the following contract revisions regarding a move to semester schedules at Lake Shore High School (LSHS) and Kennedy Middle School (KMS), effective at the start of the 2020-21 school year:

- Language referring to "trimesters" will be removed from future CBA's.
- Language mandating SSR at KMS will be removed from future CBA's.

The District and Federation shall work collaboratively during upcoming negotiations to modify contract language regarding prep time, class size, class overages, teacher lunch, other matters concerning the move to semesters.

Be it further understood that under semesters, the teacher work day shall be no longer than provisions set forth in the 2019-20 CBA and that the move to a semester schedule at LSHS and KMS has no bearing on the continuation of a three marking period schedule at the elementary level.

WHEARAS, the District and Federation agree on the aforementioned provisions regarding the move to a semester schedule at LSHS and KMS, the District furthermore agrees that effective January 24, 2020, the following on-scale adjustment shall be made to Step 23/M of the 2019-20 Salary Schedule:
