Gelman Sciences, Inc. 600 South Wagner Road Ann Arbor, Michigan 48103-9019

Chairperson Rothwell gave a brief summary analysis of the impact of the proposed expansion of the production lines at the Ann Arbor location. Gelman currently has 546 employees in Michigan.

Chairperson Rothwell then introduced Jim Donaldson of the Michigan Jobs Commission.

Mr. Donaldson first introduced Carol Sorenson, Michigan Jobs Commission. He then introduced Mike Shepers, Scio Township Manager and Susan Lackey, Washtenaw Development Council and asked Carole to introduce the principals of Gelman Sciences, Inc. to the Board.

She introduced Mr. Kim Davis, President and CEO; Ms. Karen Radtke, Treasurer; and Bob Buker, Vice President Corporation Communications.

Mr. Donaldson presented a summary of the proposed project.

Project Description

Gelman Sciences, which currently has headquarters, production, and warehousing operations in Michigan, is experiencing increased demand for certain of its products, particularly its adult IV and spiral pack filters which are used in laboratory applications. As a result of this demand, the company is considering expanding several production lines in Scio Township, Michigan. The competition for the expansion is with Pensacola Florida where the company currently has production facilities. The expansion will result in the company investing approximately \$16 million, in addition to creating 150 new jobs in 3 years. If the company locates in Michigan it will renovate its existing facilities. If it locates in Florida it will build an addition to its existing facility. The State of Florida has offered infrastructure grants, a tax abatement and job training as an incentive to locate in Florida.

Benefit to State

Based on the economic analysis done at the University of Michigan, the project will generate an annual payroll of \$4.7 million at full production. In addition to the 150 new jobs at the project, 186 spin off jobs will be created for a total of 336 jobs over the 15 year life of the MEGA award. Personal income generated as a result of the project would exceed \$200 million and net government revenues would increase by \$12.5 million.

Cost Analysis

As part of the company's site decision process, they have undertaken a comprehensive cost analysis between Pensacola, Florida, and Scio Township, Michigan. Based on figures obtained from the company, the annual cost disadvantage for Gelman Sciences Inc. to locate its expansion in Scio Township, Michigan, rather than Pensacola, Florida, ranges from \$457,000 to \$1,065,000 per year over the term of the incentive. The cost differential is primarily attributable to higher labor costs and tax costs. The wage differential between the states is 20 to 25 percent and Florida has no corporate tax.

Based on data the Michigan Jobs Commission has obtained and analyzed, we feel that the cost differential between states is a reasonable approximation. Therefore, a MEGA tax credit has been offered to reduce the variance in cost and to provide an incentive to attract this investment.

Staff Recommendation

The Michigan Jobs Commission recommends a MEGA employment credit of 100 percent for a period of 15 years. Additionally, the Michigan Jobs Commission recommends a MEGA business activity credit of 100 percent for a period of 5 years for up to 150 new employees.

Mr. McCormack asked why the number of manufacturing jobs declined in the later years of the REMI analysis. Mr. Rothwell responded that the decline was due to a reduction in spin off jobs after the company had made its capital investments and construction had concluded.

Chairperson Rothwell stated that the Executive Committee met on August 15, 1995 and recommends that the credits be awarded.

Mr. Porteous indicated that he believed it was likely that the company would locate the operation in Florida were it not for MEGA.

Member McDermott indicated her support of the recommendation.

It was moved and supported that Resolution 1995-008 awarding tax credits to Gelman Sciences, Inc. be adopted.
